New Resources

As Artificial Intelligence (AI) programs and applications have been growing in momentum for several years, AI is an important consideration in K-12 education. Our members are facing the challenge of developing policies that balance the potential of AI with necessary safeguards for student privacy, security, and equity. To support these efforts, the U.S. Department of Education [recently released a toolkit](#) designed to help educational leaders navigate this landscape. The toolkit is organized into three sections: first, it highlights the importance of managing risks by ensuring alignment with federal privacy, security, and civil rights standards. Next, it suggests that schools build a strategic, community-informed plan for using AI tools that fit their specific instructional goals. Finally, it encourages leaders to take an active role in guiding AI's use, providing resources to support educators and evaluate AI's impact on student learning. For schools looking to integrate AI responsibly, these resources offer guidance and support. Title IX Update

After the Department of Education [released new Title IX regulations in April](#) of this year, numerous subsequent lawsuits and injunctions have left districts confused on the path forward. In a [previous legal update](#), we explained that one case from Kansas issued an injunction that applies to schools in Colorado. School leadership can check if their school is covered by the injunction by reviewing lists of schools published by the three involved organizations (Moms for Liberty, Young America's Foundation, and Female Athletes United). The organizations are free to supplement the lists if there are changes, and they have been supplementing the lists since the injunction was originally ordered in July.
